Teaching

The underlying goal of my philosophy of teaching is that it important to help students to think critically and to give them certain applied skills that will enhance their academic and post-academic experience. As a

teacher, of course, my objectives for my class always begin with wanting the students to learn the subject content of the course. However, in my own experience, I have found that content, in the absence of practical skills is of limited use. Relevant skills include the ability to interpret and understand peer reviewed research, to write clearly and concisely in the appropriate style, and the use of computer applications to manipulate and analyze data. Practical skills are therefore the tools that students need to link content knowledge to the real world for the purpose of understanding, investigating, or teaching others about a given discipline. A variety of teaching approaches above and beyond didactic lectures can be used to facilitate critical thinking and learning practical skills. Students should work in groups and alone as well as participate in classroom presentations and discussions. Case studies can be an important link between the text book and the real world, interpretation of published research is useful for teaching students about study design and the careful use of causal inference, and writing their own policy or research papers provides an opportunity to integrate knowledge and to think critically about a problem. I think early introduction to "hands on" work with statistical and spreadsheet software is important for developing and understanding of statistics, the relation between research design and analytic approach, and a general understanding of the research process. It also provides a skill that is valued in the marketplace. Each of these teaching approaches provides an opportunity for assessment in addition to incremental quizzes and regular homework assignments which create an incentive for students to stay current with the work. I believe it is important to work with students one-on-one or in small groups when class size makes this practical. This enhances interest in the coursework, provides another opportunity to improve their achievement, as well as an opportunity for the teacher to identify students who are not achieving learning objectives. My view is that students are the reason for our existence as a university, and therefore, they come first in my time and priorities. Perhaps it is because I came to my new career late in life that I appreciate the value of having someone take an interest in your career and provide that extra amount of help. The reward for this type of work with students may be more immediate and obvious than that in the classroom setting, but I believe the long-term rewards are similar. I am new to teaching and therefore I am working on all aspects of my teaching. Whether I am tutoring individual students or teaching an entire class, I want to ensure that I understand the students' needs and develop curricula that are appropriate for them. My own development as a student has helped me to better understand what students require. My goal is to improve my teaching techniques. My particular concerns are putting together an entire course in a cogent manner while keeping the content interesting and relevant to the students.

Research and Original Creative Work

My research interests span divergent but overlapping areas in the domains of public health, health services research, and medical sociology. My most recent work has been in the area of outcomes research and program evaluation for pediatric asthma in Virginia. I hope to continue that work by expanding the research to include more states and larger samples of private insurance claims data for the purpose of more careful evaluation of health disparities among pediatric asthma cases in these two populations. Much of the previous descriptive work on chronic disease surveillance and epidemiology has focused on one condition at a time. I would like to more fully describe the burden of disease and disparities in medical care utilization in geographically clustered populations with a disproportionate prevalence of multiple conditions and investigate the social correlates of this population. I also have an interest in the physician workforce and particularly primary care. I have worked on projects to define primary care service areas and the identification of primary care shortage areas. Access to medical care and a medical home is important for the management of chronic conditions and reducing disparities. My dissertation research demonstrated that publicly and privately insured children with asthma benefited from higher continuity of care. I would like to continue to integrate physician workforce issues with my other research interests and examine additional health system/provider issues related to disparities in addition to patient/family level determinants. Evidence to date suggests that there are limits to what the health system and providers may be able to do with regard to reducing disparities. Providing insurance coverage and a medical home to everyone is a necessary first step but is probably not sufficient to remove disparities alone. There is strong evidence that the social determinants have a strong effect on health behaviors, health knowledge, and health beliefs. Suboptimal health behaviors are the proximal cause of many outcomes of interest. Behaviors are

likely related to aptitude, knowledge, beliefs, and even personality. These precursors of behavior are likely related to social context of the individual in addition to genetic endowment. Therefore, I think an integrative and cross disciplinary examination of the determinants of health behaviors would be useful for further explaining health disparities and would suggest behavioral interventions that may be more targeted at root causes. My other area of interest is in research and analytic methods and in particular innovative research tools. I have training in the use of Geographic Information Systems and believe they will be important for my work because so many health outcomes and the social determinants of health are clustered geographically. I have concerns that traditional regression-based approaches to analysis may have reached a point where their ability to further explain complex behaviors is limited. I would like to explore the use of agent-based simulation techniques to address this limitation. Finally, my principal mission in research is to provide answers to public policy questions and improved health for individuals. To that end, I enjoy research with direct policy implications as well as community participatory research that inform community driven interventions and evaluates their effectiveness.
