Sixteen graduate and 28 undergraduate social work programs participate in the Consortium, along with 57 county social service districts and NYC's Administration for Children's Services.

In this leadership position, I was responsible for overseeing funds allocated by the state which were used to professionalize and support the New York State Child Welfare Workforce. I directly supervised 6 employees around the completion of program deliverables. I also assisted the Director of the program with budget development and h e I p e d in decision making regarding budget modifications and expenditure variances.
